## **PILOTAGE RATES REVISION WITH EFFECT FROM 1 MARCH 2026**

1. PSA Marine ("PSAM") remains committed to delivering safe, professional, reliable, efficient and cost-competitive pilotage services to vessels calling at the Port of Singapore. In support of this commitment to excellence, PSAM continues to invest in its people, infrastructure and technology to meet the evolving demands of the maritime industry.
2. In recent years, the maritime sector has experienced significant operational and economic pressures, including rising operating costs. Amid these challenges, continued emphasis on high service quality and the long-term sustainability of the pilotage operations remains essential.
3. PSAM commenced consultation with the Singapore Shipping Association in 2025. Following approval by the Maritime and Port Authority of Singapore, PSAM will implement the revised pilotage rates with effect from 1 March 2026. Details of the revised pilotage rates are set out in the Appendix and are also available in the General Operating Conditions on the PSAM website.

- vessels requiring emergency/special assistance.
